Degenerative musculoskeletal disorders remain among the leading contributors to disability worldwide, necessitating innovative therapeutic paradigms that extend beyond symptomatic management. By contextualizing ancient Ayurvedic doctrines within contemporary clinical practice, the study underscores the enduring adaptability of classical knowledge when interpreted through systematic clinical reasoning.

Similarly, the case report addressing the ‘Ayurvedic management of aural polyp’ exemplifies the growing body of evidence documenting conservative Ayurvedic

interventions for conditions traditionally managed through invasive procedures. Such reports contribute meaningfully to the expanding literature on integrative clinical practice and emphasize the necessity for longitudinal observational studies and well-designed clinical trials capable of evaluating therapeutic effectiveness with greater methodological rigor.

The review section of this issue further enriches scholarly discourse through meticulous examination of Ayurvedic literature and medicinal plants. The ‘Meta-analytical evaluation of references to *Shatavari* (*Asparagus racemosus* Willd.) across the classical Ayurvedic Samhitas’ represents an exemplary effort in textual scholarship. Equally significant is the critical review examining ‘*Lekhaniya Mahakashaya*’ in the context of contemporary lifestyle disorders. The dramatic rise in obesity, metabolic syndrome, type 2 diabetes mellitus, cardiovascular diseases, and related chronic

conditions has transformed preventive medicine into an international healthcare priority. The article revisits classical pharmacotherapeutic concepts through a contemporary lens, encouraging researchers to evaluate traditional herbal formulations using modern experimental methodologies while remaining faithful to their Ayurvedic rationale. Such interdisciplinary scholarship exemplifies the direction in which future Ayurvedic research must continue to progress.

The comprehensive review devoted to Guduchi (*Tinospora cordifolia*) offers another compelling example of successful integration between traditional knowledge and modern biomedical evidence.
